Six year old Tori Woltering takes over Judge Carroll's courtroom

With prompting from family, friends and Spaulding staff in Laconia Family Court, a rambunctious six year old girl announced her new name, Tori Woltering, over the microphone. Judge Carroll presided over the unusual adoption proceedings giving

Tori free reign and command of the court. Much to the delight of the audience, Tori, who has boundless energy, mischievous eyes and a smile as big as a rainbow explored the front of the courtroom. She sat on Judge Carroll's lap, played with his computer, gave orders over the microphone and climbed on the chair in the witness stand.

Tori has pulled the heartstrings of many staff members at Spaulding since they began working with her two years ago, first matching her with a wonderful foster family and eventually a loving adoptive family. At the age of four, Tori needed to learn toileting skills and had limited oral communication and significant behavioral challenges. With her vitality and eagerness to learn she soon began to thrive with help from her foster family and support from clinician Liz Biron at Spaulding Youth Center.

Through Spaulding's ISO (Individual Service Option) Foster Care Program in which families become licensed, Michele and Chris Woltering of Raymond and Tori were matched. Tori needed parents with extraordinary energy and enough patience to help with her many challenges. Tori and her prospective parents got to know each other initially by visiting one weekend

per month. The time together slowly increased, but it wasn't long before the Wolterings fell in love with Tori and vice versa.

Tori has pulled the heartstrings of many staff members at Spaulding since they began working with her two years ago.

The Wolterings keep Tori busy with a variety of activities including camping, bowling, Zumba and soccer. This past summer they attended a series of fairy tale performances at the Palace Theatre in Manchester where Tori dressed up like one of the characters for each performance. She also threw out the first pitch at a Fisher Cats game. Tori has embraced her many new relatives and loves to spend time on her grandparents' farm where she mucks out the chicken coop and collects eggs. To see Tori with her new family, one would think they had been together forever.



A Young Man Learns to Trust and Love

Matt is a young man to whom you may have spoken while pushing your shopping cart down the aisle of a local grocery store. His association with Spaulding began at the age of six when he was separated from his parents by the court system and referred to Spaulding for residential treatment and academic services. Matt was understandably a very unhappy child and his challenges were numerous, including the inability to speak in sentences and lack of self-control. “No” was his favorite word and he was afraid of every new experience.



With lots of attention from expert and caring staff members at Spaulding who taught him with kindness, consistency and repetition, he learned to speak in sentences, relate to the world around him, to use his strengths to his advantage and to deal with his weaknesses. Matt who is now 23 years of age lives with a wonderful family and spends a good deal of time with his legal guardian Melonie Bell and her large family. Weekdays, Matt is in a program where he works in a grocery store and is paid to stock and face shelves. He also volunteers his time delivering Meals on Wheels and serving meals at the Trip Center in Franklin where he is a big hit.

Melonie who has known Matt since he was six says that he has come a long way. He knows how to cook using picture recipes, grocery shop, budget his paycheck, do laundry and keep his own room tidy and clean. Melonie says that Matt has become a very important part of their family.

Terrance, Holly and Thaddeus Humphrey are huge fans of Spaulding and because of their longtime relationship have a solid understanding and deep appreciation of the organization. The Humphreys' love affair with Spaulding began when their son Thaddeus, who is on the autism spectrum, was five years old. At that time they lived in Northern New Hampshire and were looking for a placement for him. Upon touring Spaulding they were so impressed that they immediately moved to the area so that Thaddeus could attend school here.

And that was only the beginning of their involvement. Terrance worked as a family therapist at Spaulding for ten years and after starting his own practice as a marriage and family therapist became a Board member. Holly volunteered her time helping families teach their children to transfer basic skills such as toileting to life at home. Terrance presently serves on the Board of Trustees and is the secretary of the Board of Directors. As donors the Humphreys generously support the New School Campaign and have been members of the Spaulding

Sunshine Society supporting the Annual Fund for many years. Terrance and Holly believe that Spaulding is doing the "right" job and they get a lot of satisfaction being involved with a local organization where their gifts directly support the students.



Holly and Terrance commented that Thaddeus talks about Spaulding often with great fondness relaying good memories such as his participation in the ground breaking of Lambert Cottage where he dug the first shovelful of dirt when he was five. Thaddeus loved the expert, dedicated and caring staff and made friends with several boys, which the Humphreys believe would be impossible for a boy with his involvement with Autism in a public school setting. Holly commented that the staff and students felt like family and they made a huge difference in Thaddeus' life. At the dedication for the new school in 2012, Holly commented that she was very moved by the ceremony and by the students, especially the two delightful and well-mannered boys who conducted the school tour. "The students are very happy here; they have friends and they are very proud of their new school."
