AFFIDAVIT OF MERGER

1. I am President of Spaulding Youth Center, a New Hampshire voluntary corporation with the same address as stated above.

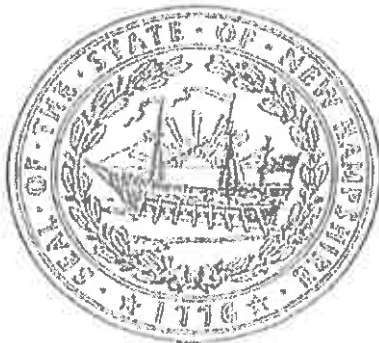
